



SMP PAINT WARRANTY

Legacy Metalworks, LLC (hereafter referred to as Legacy) provides this limited warranty for SMP-painted steel, to be used as exterior roofing and siding. This warranty is subject to the conditions and exclusions that follow:

Registration:

The property owners must, within 90 days of completion of installation, complete a warranty registration card, and mail it to Legacy. Legacy will then issue a registered warranty card complete with the registration number. The registered warranty card must be produced if/when a claim is to be made.

Performance:

Legacy Metalworks, LLC warrants that the panel coating will not, under normal atmospheric conditions:

- A. Chip, Crack, Check, or Peel for a period of 40 years (except such crazing/cracking that may occur with normal brake bending or rollforming).
- B. Chalk in excess of a numerical rating of 8 for a period of 30 years from installation date, using the standard procedure of ASTM D-659 on vertical (sidewall).
- C. Fade or change color, for a period of 30 years from installation date, more than 5 E units on vertical (sidewall) and 7 E units for horizontal (roofing), to be calculated in accordance with ASTM D-2244. The color change is to be measured on exposed painted surface cleaned of dirt and chalk.

Transfer:

This Warranty is limited to the purchasing property owner(s), and not transferable to any other owner. In the event of multiple owners, coverage terminates on the death of the last purchasing owner.

Claims Procedure:

All claims must be made known to Legacy within 30 days after the defect is discovered, either by phone at 541-632-4260, or by mail to P.O. Box 205, Harrisburg, OR 97446. Ample opportunity to inspect the product must be given to Legacy, and to inspectors from Legacy's supplier of the product in question.

Legacy's Liability under this warranty:

If Legacy, by the terms of this warranty, finds the panel coating to be defective, Legacy will, at its option, Repair, Replace, or Refinish the defective product, or refund original purchase price. Legacy must be notified of the damage within 30 days of discovery of the failure, and must be allowed onsite to inspect damage.

Legacy will not be liable for labor cost or incidental damage during the replacement/repair of the product.

Conditions/Exclusions:

- A. This warranty only covers product installed in the continental United States, in areas exposed to normal atmospheric conditions.
- B. This warranty does not cover product installed within 1,500 feet of a salt-water environment.
- C. This warranty does not apply to product surface that has been repainted, or altered in any way.
- D. This warranty does not include failures resulting from standing water. When used as roofing, the product must be installed with a minimum of ¼:12 pitch.
- E. Product under this warranty must be washed regularly with fresh water or a 5% solution of mild detergent. Product may not be pressure with settings exceeding 1,000 PSI and 4 GPM, or cleaned with any kind of abrasive materials or chemical cleaners.

THIS WARRANTY IS LIMITED TO FAILURES RESULTING FROM NORMAL WEATHERING, AND DOES NOT COVER DAMAGES CAUSED BY SCRATCHES OR SCRAPES. THIS WARRANTY DOES NOT COVER DAMAGES CAUSED BY EXTERNAL FORCES OUT OF LEGACY METALWORKS' CONTROL, SUCH AS FALLING OBJECTS, RADIATION, ACTS OF GOD, EXPLOSIONS, CHEMICAL CORROSION, ETC.
